

President Watkins called the regular meeting to order at 12:30 p.m., and Manager Hopkins led the Pledge of Allegiance.

Present at roll call at the District were Directors McGaughey, McGurk, Panizza and Watkins. Also present were Manager Hopkins, Assistant Manager Vega, District Engineer Evensen, Finance Director Ram, Administrative Services Manager Carido, Administrative Clerk Feliciano, Legal Counsel Zolezzi and Consultant Barkett. Directors Atkins, Cortopassi and Sanguinetti were absent.

4. United States Army Corps of Engineers – Memorandum of Agreement Section 214, 10/04/22 Manager Hopkins provided the Board with a Board Memo for a United States Army Corps of Engineers – Memorandum of Agreement Section 214. Manager Hopkins reported the District has several projects in waterways under the jurisdiction of the United States Army Corps of Engineers (USACE) through the Central Valley Flood Protection Board which require Section 408 permitting. Manager Hopkins stated the District is having a difficult time getting USACE to produce any work in regards to the obtaining the necessary approvals and permits for project construction to begin. Manager Hopkins reported the District has eight projects that require USACE Section 408 permits, of which four projects are fully grant funded by the Department of Water Resources (DWR). Manager Hopkins reported District Staff has repeatedly appealed to the USACE to speed up approvals, and also with the help of Consultant Barkett, reached out to Congressman McNerney and Representative Harder to inquire if their support would help; all attempts have been unsuccessful. Manager Hopkins reported the USACE provides an option to enter into a Memorandum of Agreement Section 214 which provides permit review funding for specific projects; these projects receive the highest priority and continue to be reviewed when federal funding is not available. Manager Hopkins reported under District Staff's proposal, an estimated \$100,000 would be set aside for payment of USACE review time for the four projects currently funded by a DWR grant. Manager Hopkins inquired if the Board is in support of Manager Hopkins providing Legal Counsel Zolezzi a USACE Memorandum of Agreement for review; upon approval of the draft Memorandum of Agreement by the USACE, District Staff will present the Memorandum of Agreement to the Board for approval.

Legal Counsel Zolezzi inquired if the \$100,000 covers all of the projects presented. Manager Hopkins replied the \$100,000 is an estimated cost for the four grant funded projects; the process requires we draft an agreement for Stockton East Water District and USACE estimates the cost per project.

Director McGurk inquired if the USACE will provide the District with an itemized receipt. Legal Counsel Zolezzi replied yes, however it will not be detailed. Director McGurk inquired if Manager Hopkins has the request for the Section 214 Agreement in writing for legitimacy reasons. District Engineer Evensen replied other entities have entered into Section 214 Agreements and unfortunately it is the only option to speed up the permitting process in order to execute projects. President Watkins inquired if this is the same issue the DREAM Project is facing. Manager Hopkins replied yes, it is the same issue.

Consultant Barkett commented the USACE budgets a certain amount for reviewing Section 408 permits and once that amount is expended they stop; spending the money per an agreement ensures the District will have staff working on our projects. Consultant Barkett reported he worked on a project with SJAFCA and it took 8 years to get the Section 408 permit completed; SJAFCA was presented with the option to enter into a Memorandum of Agreement to complete the project.

President Watkins inquired if the District is in danger of losing grant funding. Manager Hopkins replied he is in communication with DWR about the possibility of extending the funding deadline. Manager Hopkins explained the Hosie Low Water Crossing was planned to be completed last summer and the funding was awarded almost two years ago.

Board Meeting – 10/04/22 Draft President Watkins stated the USACE Memorandum of Agreement Section 214 should be drafted for the four grant funded projects for now and should the Board decide to use the same process again for the other District projects, another Memorandum of Agreement could be drafted.

Manager Hopkins reported the USACE Memorandum of Agreement Section 214 will be drafted to only include the four grant funded projects and once it has been reviewed by Legal Counsel and the USACE, it will return to the Board for approval.

### E. COMMITTEE REPORTS

1. San Joaquin Farm Bureau Federation Water Committee Meeting, 09/27/22

Directors Sanguinetti, Watkins and Manager Hopkins attended the September 27, 2022 San Joaquin Farm Bureau Federation Water Committee Meeting. Manager Hopkins reported East Bay Municipal Utility District is working on a project to reline one of their aqueduct pipelines from 8 Mile Rd. to Hildreth Lane. Manager Hopkins reported North San Joaquin Water Conservation District is looking for funding to rehabilitate their north pipeline and north pumping plant system; they are also looking to hire a General Manager. Manager Hopkins reported Central and South Delta are still fighting over riparian rights issues with the State. Manager Hopkins stated Oakdale and South San Joaquin Irrigation Districts reported they have water. Manager Hopkins reported a member of the United States Department of Agriculture (USDA) gave an update regarding RCCP funding which will be advertised soon; it will provide funding for groundwater recharge for a watershed level project or program and does not have a monetary matching requirement. President Watkins reported they have \$8 billion of available funding. Director McGurk inquired if individual farmers could apply for grants as well. President Watkins replied the watershed program would be given the funding and then it was unknown how those funds will be distributed. President Watkins added this is the time to get involved in the process because all those factors can be discussed and decided at the ground level. President Watkins stated USDA has already done pilot projects down south. Manager Hopkins reported the San Joaquin County gave a presentation on the 100-year flood zones. President Watkins reported the County identified zones that would require a variance to build but even with the variance, flood insurance is still required. President Watkins reported the County has also been out of compliance for years and they are making moves to get back into compliance. The next scheduled meeting is October 25, 2022.

### F. REPORT OF GENERAL MANAGER

1. Water Supply Report as of 09/26/22

Manager Hopkins provided a handout of the Water Supply Report for information only that included storage, release, and production data collected from various sources as of midnight last night.

There is 55,251 AF in storage at New Hogan Reservoir. Current releases are set at 147 cfs. Current release at Goodwin Dam to Stanislaus River are set at 154 cfs and release to all water users are set at 0 cfs. There are 10 irrigators on New Hogan, 0 irrigators on New Melones, and 0 irrigators out of District. The water treatment plant is currently processing 46 mgd. The City of Stockton is currently processing 13 mgd. Manager Hopkins reported the District wells total water extraction is 6,823 gpm (~9.8 mgd).

- 3. Report on General Manager Activities
  - a. Potential Recharge Projects Meeting with Growers, 09/28/22

President Watkins, Manager Hopkins and District Engineer Evensen attended the September 28, 2022 Potential Recharge Projects Meeting with Growers. Manager Hopkins reported three growers attended the meeting; novel recharge methods of reverse tile drain and dry well recharge systems were discussed. Manager Hopkins reported the meeting went well and there is a follow up meeting on Wednesday, October 5, 2022 with one grower to discuss moving forward on a pilot project this fall; the pilot project would allow the District to put storm water to use and see how the system works next year with a crop. This item was for information only.

### b. Stockton East Water District Activities Update

Manager Hopkins provided a handout for the Board regarding a letter received on October 3, 2022 from the San Joaquin County Registrar of Voters (ROV). Manager Hopkins reported the ROV disclosed an error on the ballot which excludes the two Board Directors that are being contested this election. Manager Hopkins reported the ROV approach to correct the issue is to send out a supplemental ballot for all the voters voting for Stockton East Water District candidates which will be submitted along with the original ballots. Manager Hopkins added the supplemental ballots will be counted separately. Director Panizza inquired if the voters will have instruction on the process. Manager Hopkins replied the ROV ensured that voters will be instructed to not discard their original ballots and to complete and submit both the original and supplemental ballots; the supplemental ballot will be submitted in a yellow envelope and the original ballot in a blue envelope. Manager Hopkins reported the ROV will be sending out a press release, post cards, information on their website and a letter; the ROV will be covering all the supplemental costs and the candidate statements will still be printed and sent out to the voters.

Manager Hopkins reported the State Water Resources Control Board voted to cancel the City of Stockton Water Right Application yesterday; the City of Stockton will have to reapply if they want to pursue that water.

Manager Hopkins reported due to the promotion of Juan Vega to Assistant General Manager that left a vacancy in the Finance Director position; the position is fairly complicated and requires knowledge of the budget and how funds are managed which could take years of training and mistakes to be as proficient as the previous Finance Director. Manager Hopkins promoted Priya Ram, Accountant to the position of Finance Director. The Board congratulated Finance Director Ram on her promotion to Finance Director. Manager Hopkins stated the District is now recruiting for an Accountant. This item was for information only.



Re: Highway 4 Traveling Water Screens and Conveyor System

### Background

As a part of the Stockton East Water District's (District) FY 22-23 budget, the Board of Directors (Board) approved a \$450,000 budget to install traveling water screens and a conveyor system at the Lower Farmington Canal Highway 4 siphons. The Lower Farmington Canal provides water from New Melones to District agricultural customers, the Dr. Joe Waidhofer Water Treatment Plant via Peters Pipeline and Central San Joaquin Water Conservation District.

### **Summary**

The proposed Highway 4 traveling water screen and conveyor system installation will be located at the inlets of the Lower Farmington Canal siphons under Highway 4. The traveling water screen will run periodically to remove weeds and other debris from the canal. Several other traveling water screens and conveyor systems have successfully been installed along the Lower Farmington Canal, with the most recent installation being at Funck Rd as seen in Figure 1.



Figure 1. Funck Rd Traveling Water Screen and Conveyor System

The existing structure includes two 66" RCP siphons and rip rap as seen in Figure 2. No screens are currently used at the Hwy 4 siphons allowing debris to enter and clog the siphons or continue to the Duck Creek siphon traveling water screens downstream overloading the Duck Creek screens.

District staff has standardized the traveling screen systems with International Water Screens (IWS) for consistent mechanical, electrical components and spare parts. IWS submitted a quote for two new traveling water screens and conveyor belts for \$331,365.

### Recommendation

Staff recommends the Board authorize the General Manager to purchase the two traveling water screens, conveyor belts, and control panel from International Water Screens in the amount of \$331,365, plus a 10% contingency, for a total approved amount of \$364,502.



Dear Mr. Hightower:

We received comments submitted by the City of Stockton Municipal Utilities Department, California Water Service Company and San Joaquin County (collectively, the "UCs") dated August 11, 2022 on the draft Municipal Service Review (MSR) prepared for consolidation of Stockton East Water District (Stockton East) and Central San Joaquin Water conservation District (Central).

The UCs generally object to being included within the boundaries of Stockton East, and chafe at the idea that Stockton East can impose charges within their boundaries. They wish to have the legislation governing the District amended, and to strip Stockton East of many of its powers. This is reminiscent of the contentious issues that existed at the time of creation of Stockton East, and adoption of the special legislation in 1971, when the legislature found and declared that:

... the district includes within its territory a large urban area, a large agricultural area, and territory formerly within an irrigation district, and that for these reasons it is necessary in order to accommodate the various interests within the district to provide special procedures to be observed by the district in its government and operation.

### And further found and declared that:

. . . only a portion of the City of Stockton and only a portion of the Metropolitan Stockton Planning Area as defined by the City of Stockton and the County of San Joaquin are within the district, and that unless all of such city and all of the Metropolitan Stockton Planning Area are within the district there will be uneconomic duplications and inefficiencies and it will be both more costly and more difficult to solve the grave and urgent water problems of the Stockton Metropolitan Area and the existing Stockton-East Water District.

Despite the statements of the UCs and the creation of SGMA, none of those circumstances described by the legislature in 1971 have changed.

This history of tension between Stockton East's agricultural and urban areas is important to note, because all but one of the questions and concerns raised by the UCs have nothing to do with either the LAFCO process of consolidation or the requirements imposed by the law on municipal service reviews, but involve the legislation to govern the consolidated district. As to the MSR itself, Government Code Section 56430 requires that LAFCO "shall prepare a written statement of its determinations with respect to each of the six items required to be reviewed in a MSR. The UCs provide comments on three of the six items subject to review, some of which are only tangentially related to those items. The UC comments are included in bold.

1. Present and planned capacity of public facilities and adequacy of public services, including infrastructure needs or deficiencies.

As stated in San Joaquin LAFCOs Service Review Policies (Adopted September 21, 2007, Amended February 15, 2008, Amended 10/21/2011, December 14, 2012), this:

Refers to the status of existing and planned public facilities and its relationship to the quality and levels of service that are, can and need to be provided. Infrastructure needs and deficiencies can be evaluated in terms of supply, capacity, condition of facilities, and service quality with correlations to operational, capital improvement, and finance plans. Maps and explanatory text that clearly indicate the location of existing facilities and proposed facilities, including a plan for the timing and location of new or expanded facilities need to be included. The identification of the anticipated service level needs to be tailored to the 5-10, and 30 year sphere horizons.

The discussion focuses on <u>capacity</u> of public facilities and service levels, and infrastructure needs, which are discussed in the MSR. In addition, the MSR summarizes the current and future demands as well as the current and future supplies available to Stockton East and Central. These supplies are of course affected by drought, and will be affected by climate change. However, the proposed consolidated will not increase the current or future demands of, and will have no impact on the supplies available to, either district or the urban area.

a. Future Reliability. The UC letter asserts:

SEWD has not provided a discussion in the MSR regarding the future reliability of surface and groundwater supplies needed to meet future UC demands. Several factors have arisen in the State that could significantly impact SEWD's supplies including:

- Climate Change and continued drought conditions,
- State Water Board's action on the Bay-Delta Plan flow criteria for the Stanislaus River, and
- Bureau of Reclamation's (BOR) use of the San Joaquin River Index to determine annual water allocations from New Melones Reservoir.

Stockton East has addressed these ongoing issues internally, and investigations of this level are not of the type to be addressed under adequacy of public facilities in the MSR. Rather, the legislature has imposed requirements on water districts to evaluate these supply and demand issues through urban water management plans and agricultural water management plans, which the UCs, Stockton East, and Central regularly complete. LAFCO should be entitled to rely upon investigation and conclusions reach in these other documents, and summarized in the MSR.

In addition, the City of Stockton's Sphere of Influence Plan/Municipal Service Review prepared in 2020 for San Joaquin LAFCO evaluates water supplies and, regarding the supply-demand comparison, reached the conclusion at p. 5-38, that

Table 5-19 shows the relationship between the demand totals described in Table 5-17 and the supply totals described in Table 5-18. As it demonstrates, according to the UWMPs prepared for COSMUD, Cal Water, and SEWD, the identified supplies far exceed demand associated with projected growth in the SOI. This is attributable to the fact that the City of Stockton has secured water supply rights, largely through the DWSP, that address the potential for development beyond the current SOI.

Further, in its Water Supply and Treatment Determinations section, at p 5-41, the City concludes:

The City of Stockton Metropolitan Area has met and expects to be able to continue to meet annual water demands within the SOI during differing hydrologic periods with surface water, groundwater, water conservation, and other potential water supplies such as non-potable supplies from local communities, raw surface water from local irrigation districts, and water from active groundwater storage projects. According to the 2015 Urban Water Management Plans prepared for the City of Stockton, Cal Water, and the Stockton East Water District, there is more than sufficient water available to support projected development within the SOI.

These conclusions were accepted by LAFCO, and each of the "issues" raised by the UCs were known as the time of preparation of this document by the City of Stockton, and its acceptance by San Joaquin LAFCO. The lending MSR should be treated not differently that the City of Stockton's MSR adopted a mere two years ago.

b. <u>Past Droughts</u>. The UC letter also states: "During past droughts, SEWD was challenged to deliver the base supply of 20,000 acre-feet (2014-15) and has often delivered water of substandard quality that has caused UC customers to complain about taste and odor". This statement is simply untrue. As shown in **Table 1**, Stockton East has never delivered less than the base supply to the UCs, and it has never been a "challenge" to do so. Stockton East has stored surface water in the underground for the past decades to be able to meet water supplies to the UCs during an extended drought such as currently being experienced.

As is well known by the UCs, taste and odor problems historically occurred in the late summer months when water was served from the Calaveras River to the treatment plant. Stockton East has taken action to alleviate this issue, and there have been no taste and odor problems in recent years.

- c. <u>Inclusion in MSR/Capital Improvement Plan</u>. The UCs conclude: "A complete evaluation and development of an effective Capital Improvement Plan, supported by the UCs, to address these changes in water supply availability should be required as a condition of any consolidation between the districts". This request has nothing to do with the MSR, but it is also an inappropriate conditions for a consolidation. The Second Amended Contract by which the UCs are provided with water from Stockton East contractually guarantees them receipt of the first 20,000 acre feet of water available to the district; <u>consolidation of the two districts will have no effect on that contractual obligation</u>, or availability of water to the UCs. As mentioned above, the legislature has imposed independent requirements upon the UCs, Stockton East and Central to address changes in water supply availability, which have been met through preparation of urban water management plans and agricultural water management plans, which the UCs, Stockton East, and Central have prepared and continually updated.
- d. Amendment to Special Act. Finally, the UCs attempt to shoehorn their displeasure with Stockton East's current authority under the adequacy of facilities bullet point, and state that "[t]he MSR's approval and the consolidation of the two districts should be contingent upon revising the Special Act to eliminate this conflict and revisions to SEWD's service area should be completed."

Their assertion that "the jurisdictional boundary defined in the Special Act that includes SEWD's groundwater management responsibilities should be revised to limit the new Consolidated District's ability to impose assessments to only those areas where it has groundwater management responsibility under SGMA" may be their opinion and their hope, but it is not related to the MSR, or subject to LAFCO's authority to condition consolidation.

Furthermore, the California legislature developed the special legislation governing Stockton East. The Legislature also passed the Sustainable Groundwater Management Act, and did not make any revisions to the laws governing Stockton East when it did so. It may be the opinion of the UCs that

changes are needed to the special act governing the district, but that is clearly not the position of the California legislature, and is not the position of Stockton East or Central. The authority to impose groundwater assessments is held by numerous water districts in California, not just Stockton East and Central; and the purpose of such fees are not just to "discourage excessive groundwater pumping and encourage surface water use," as stated by the UCs, but also to generate funds to undertake projects to improve groundwater conditions. The need for such projects remains, and the authority to impose municipal groundwater charges is essential to the original purpose of Stockton East as established by the legislature, which has not changed despite adoption of SGMA.

2. **Financial Ability of Agencies to Provide Services**. As stated in San Joaquin LAFCOs Service Review Policies (Adopted September 21, 2007, Amended February 15, 2008, Amended 10/21/2011, December 14, 2012), this:

A community's public service needs should be viewed in light of the resources available to fund the services. The MSR will need to evaluate factors that affect the financing of necessary improvements and whether agencies are capitalizing on financing opportunities and collaborative strategies to deal with financial constraints.

Again, the UCs take the opportunity to provide public comment on the Draft MSR as a chance to raise issues of displeasure with Stockton East that are outside of the MSR criteria. The UCs express their displeasure with Stockton East's use of property tax revenue, and requests "SEWD should provide an explanation in the MSR as to how the transfer and use of these funds by the Agriculture Division is justified and legally appropriate". This disagreement is a private one between the UCs and Stockton East; the MSR meets the required criteria of discussing the financial ability of Stockton East and Central to provide services, and the issue of how individual revenue sources are used should not be a part of the MSR review or LAFCO's consideration of consolidation.

3. Accountability for Community Service Needs, Including Governmental Structure and Operation Efficiencies. As stated in San Joaquin LAFCOs Service Review Policies (Adopted September 21, 2007, Amended February 15, 2008, Amended 10/21/2011, December 14, 2012), this:

The MSR will consider the advantages and disadvantages of various government structures that could provide public services. San Joaquin LAFCo encourages local agencies to use service reviews to determine whether initiation of proceedings for changes of organization and reorganization, including spheres of influence, would be in order and in the best interests of the agency and the community it serves. LAFCo will examine efficiencies that could be gained through: (1) functional reorganizations within existing agencies; (2) amending or updating spheres of influence; (3) annexations or detachments from cities or special districts; (4) formation of new special districts; (5) special district dissolutions; (6) merges or special districts with cities; (7) establishment of subsidiary districts; or (8) any additional reorganization options found in the LAFCo statute.

Operational efficiency refers to the quality of public services and the agency's ability to provide services. Efficiently managed entities consistently implement plans to improve service delivery, reduce waste, eliminate duplications of effort, contain costs, build and maintain adequate contingency reserves, and encourage open dialogues with the public and other public and private agencies. The MSR will evaluate operational efficiency by analyzing agency functions, operations, and practices as well as the agency's ability to meet current and future service demands.

- a. New Consolidated District Board of Directors. While this is finally an issue within LAFCO's jurisdiction, it is not an issue for the MSR, but for future consolidation. However, the issue raised by the UCs has already been addressed by the districts in their request for consolidation, and the solution suggested by the UCs goes far beyond LAFCO's authority and any need resulting from the temporary short-term addition of two board of directors.
- i. Added Directors. As stated in the districts' application for consolidation, the two new temporary directors will abstain from voting on any items before the Board pertaining to the Municipal Division and/or on any items before Committees or Sub-committees of the Board that address Municipal Division activities or budgets. The UCs are requesting that a description of the temporary Board member powers and authorities should be codified within the Bylaws of the Consolidated District, included within any founding legislation, and established as a condition of consolidation. The districts contemplate that this restriction would be included as a condition of the consolidation; the additional requests that legislation and bylaws be amended for a temporary four-year board member term are overreaching and unnecessary.
- ii. *Method of Voting.* When the California legislature established Stockton East's Board of Directors, they provided:
  - SEC. 32. Notwithstanding Section 74091 of the Water Code and any other provisions of law in conflict with this section, one director, who shall be an elector of the division in which such director resides, shall be elected for such division, by vote of the electors of the entire district.

The legislature further divided the district into seven divisions.

The UCs allege that election by all voters within the District, as opposed to election of specific representatives by each zone within the District, "dilutes the representation of the UCs within the SEWD". The UCs further allege that "If CSJWCD's service area is added to SEWD's in a Consolidated District and Directors continue to be appointed using SEWD's system, the dilution of representation of the UCs will be further exacerbated". The UCs propose that: "members of the Consolidated District's Board of Directors be elected by specific zones within the district as is currently the case in the CSJWCD..."

The logic of the UCs is difficult to follow. Any director from a division must <u>reside</u> in that division. The fact that the directors are <u>elected</u> by vote of the electors of the entire district does nothing to "dilute" representation, as the director must live in the appropriate division – voting cannot change that. The legislature felt it important that the directors of Stockton East, which included the agricultural and urban area in the greater Stockton area, be elected by the entire district, and consolidation with Central will not change that.

iii. Division into Zones. The UCs further request that the seven divisions within Stockton East and the consolidated district "be created with reference to the number of water users within each zone to create a level playing field in which the UCs and their ratepayers are adequately represented".

This suggestion is contrary to California law, and would defeat the goal of Stockton East's special legislation to <u>balance</u> representation between agricultural and urban interests. Contrary to leveling the playing field, in fact, drawing division boundaries based upon population alone would result in

almost all divisions being elected by the urban area. Stockton East was originally established with seven directors from seven divisions: three divisions were drawn in the agricultural area, and three divisions were drawn in the urban area. The final seventh division straddled the ag/urban line. Therefore, the district was formed with, and has to this day, 3.5 divisions representing the agricultural area and 3.5 divisions representing the urban area. It is essential that this balance be maintained, and not "diluted."

Stockton East's special legislation requires that it adjust its boundaries in accordance with Water Code section 74430 et seq. When the special legislation was enacted, section 74430 provided that Stockton East's division boundaries should be adjusted according to <u>area</u>, while Sections 74434 and 74435 of the Water Code require division boundaries to be adjusted according to area when "land is included within a district" or "another district is annexed to a district."

In 1998, AB 2543 amended section 74430 to require that division boundaries be adjusted according to population pursuant to section 22000 of the Elections Code; however, AB 2543 applied to numerous general act districts, and 10 special act districts, but not to Stockton East. In fact, by its own terms, Election code section 22000 does not apply to Stockton East because Stockton East's directors are all elected at large. Therefore, in 1998 the legislation made very clear that it is intended that Stockton East maintain its seven divisions being divided in accordance with area, to continue to balance divisions between ag and urban, rather than by population.

b. Stockton East Water District Use of the Special Act of 1971 ("Special Act"). Finally, the UCs reveal the true intent of their opposition to consolidation and comments on the MSR. The UCs are concerned that the district's "Special Act, now over 50 years old, will govern the new Consolidated District. Unfortunately, the Special Act contains numerous antiquated legislative provisions (12 entire sections) that are no longer operative or of any legislative pertinence. To organize the new Consolidated District under the amended "Special Act" statutes of 1971 is concerning to the UCs in that some statutory language, after nearly 50 years, is outdated, inaccurate, and possibly inconsistent with current California law.

Then the UCs point to several examples:

### The UCs state that SGMA should control management of the groundwater basin, and there is no place for Stockton East to do so.

This is not an issue confined to the special legislation governing Stockton East. Stockton East's special legislation provides that the district "shall continue to be organized under; and governed by, the Water Conservation District Law of 1931," and that law governs Central. However, if Stockton East and Central are consolidated pursuant to the Water Conservation District law rather than the special legislation, the consolidated district would still have the authority to impose groundwater assessments on the UCs. Most water districts created under the water code have authority to impose groundwater assessment on all uses, agriculture and municipal included; this is not peculiar to Stockton East's special legislation. In addition, most of the laws governing water districts in California are more than 50 years old: the law governing irrigation districts was adopted by the legislature in 1943 (Water Code Section 20500 et seq.), the law governing water conservation districts (including Stockton East and Central) was adopted by the legislature in 1931 (Water Code Section 74000 et seq.), the law governing California Water Districts was adopted by the legislature in 1951 (Water Code Section 34000 et seq.). The legislature is charged with updating both generic water district statutes and special legislation if its sees conflicts with SGMA.

Furthermore, the actual municipal groundwater assessments that are imposed by Stockton East do not derive from either its special legislation or water conservation district law, rather, they are imposed as a <u>contractual requirement</u> of the Second Amended Contract (SAC) between Stockton East and the UCs by which the UCs are provided water from Stockton Easts water treatment plant. Section 6D(3) of the SAC provides that Stockton East shall levy a municipal groundwater assessment sufficient to make the cost of groundwater use equivalent to the cost of surface water use in the municipal area. As a result, revision of Stockton East's special legislation would not eliminate this independent contractual obligation.

### The UCs state that their increased use of surface water has resulted in recovery of the groundwater basin.

While this statement is true, the majority of the surface water used by the urban area to accomplish this recovery is provided by Stockton East. The fact that the requirements of the Special Legislation has been successful is no reason to eliminate its requirements. But, again, this choice is one for the legislature to address, not the UCs and not LAFCo.

The UCs state that there is no longer an urgent groundwater problem, and no need for the City to be included in the consolidated district. The UCs then propose specific amendments to the Special Act to accommodate the cities interest.

This is not for the UCs to determine. This conflict between agricultural and urban interests was recognized by the legislation in 1971 when it stated:

the district includes within its territory a large urban area, a large agricultural area, and territory formerly within an irrigation district, and that for these reasons it is necessary in order to accommodate the various interests within the district to provide special procedures to be observed by the district in its government and operation.

And obviously the conflict and special procedures is still required. The legislature has updated the special legislation as recently as 2022 (SB 656), and did not see fit to make any changes reconciling the special legislation to SGMA.

c. <u>Props. 218 & 26 Compliance</u>. The Special Act's provisions authorize SEWD to undertake a broad set of water management and supply development activities to address historic overdraft conditions in the basin. These activities range from direct recharge programs to support the overall health of the basin to targeted activities (e.g., sale of imported surface water supplies) that indirectly improve the overall basin through reduced pumping. SEWD is authorized to recover the cost of these activities through a range of funding mechanisms (i.e., rates, charges, and assessment) that were established before current regulations governing cost allocation among customers.

It is not clear what the UCs are after here, but certainly they understand that any and all funding authority granted to either Stockton East or Central are subject to the requirement of the California Constitution and statutory law, including, but not limited to Proposition 218 and 26. Again, this is not unique to Stockton East's special legislation; Prop 218 and 26 impose funding requirements upon any and all funding mechanisms held by any special district in California.

- 4. **Conclusion**. Finally, the UCs state that the MSR's approval and the proposed consolidation should be contingent upon the following:
  - a. Revising the Special Act to ensure that the cost and benefits of SEWD water management and supply development activities accrue to the appropriate parties consistent with current law governing cost recovery (e.g., Props. 218 & 26) and groundwater management (i.e., SGMA), as well as SEWD's contractual commitments.
  - b. Revising the Special Act and/or enacting new legislation that would define the future powers and authorities of the new Consolidated District, and
  - c. Revising antiquated Special Act provisions as needed to ensure that the new district organization and boundaries are established in harmony with SGMA and other relevant contemporary laws and that outdated provisions are removed.

The UCs would have San Joaquin LAFCo undertake the job of the legislature in re-writing the special legislation governing the district prior to consolidation between Stockton East and Central. As described above, Stockton East's special legislation is still vital, and essential for continued balance between agricultural and urban interests in the Eastern San Joaquin Groundwater basin. Municipal interests are expressly protected, and their interests balanced against agricultural interests, as intended by the special legislation. Consolidation under the Water Conservation District law, under which Central is currently exclusively governed, would not maintain that balance, because it would require that the seven division in the consolidated district be drawn to equally distribute population, and would skew representation almost exclusively to the urban area. Conversely, consolidation under the special legislation will not shift the current carefully drafted balance between agricultural and urban interests, but insure that it continues.
